MARCH 28th, 29th, and 30th, 2008

LOCATION: Southport Gun Club, 7401 75th Street, Kenosha, WI. Three miles east of I94 on Hy. 50.

ELIGIBILITY: **Competitors must be members of the NRA. State association membership is required and you will be required to show a current membership card. No exceptions!**

FEES: .22 cal only - \$30.00 Across the board ---\$40.00

ENTRY: Limited to 50 shooters. Three Days, 5 relays with 10 competitors per relay.

FACILITIES: 10 point 50 foot range with turning target targets.

AWARDS: Number of competitors required for the class awards: 5 for 1st place, 10 for 2nd place, and 15 for 3rd place and 20 for 4th place. Any class with less than 5 competitors will be grouped in the next higher class. If the High Master class has fewer than 5 shooters, they will be eligible for Match Winner only.

Match Winner	\$5.00 or NRA Points
1st in class	\$4.00 or NRA Points
2nd in class	\$3.00 or NRA Points
3rd in class	\$2.00 or NRA Points
4th in class	\$1.00 or NRA Point

- NOTES:
1. This is an NRA registered tournament and all NRA rules apply.
 2. Challenge fee --- \$2.00(returned if sustained)
 3. Competitors will be classified according to the most current NRA classification system. Classification card, or temporary score book, MUST be shown during check in. NRA and state association cards must also be shown.
 4. Competitors will score and change targets. Overlays may be used – only range staff will plug.
 5. If you wish to be eligible to be State Champion, you must shoot the .45 in the center fire national match course, Match # 7.
 6. Do not send fees prior to obtaining relay confirmation either by email or phone. If you must cancel, please call. No Call = No Refund. There will be a \$5.00 charge deducted from refund if cancellation is three (3) days, or less, prior to the match.
 7. Reservation preference will be given to across the board shooters.

There will be snacks, coffee, pop, and bottled water available throughout the day.
