

Wisconsin Conventional Smallbore Prone Championship

TO BE HELD AT THE RACINE COUNTY LINE RIFLE CLUB

DATE: September 12, 13, 2009 (entries close 8:00 am Match starts at 9:00 am)

LOCATION: The Racine County Line Rifle Club range, approximately 6 miles east of I-94. Turn off (7 Mile RD. exit) Head east On 7 Mile RD. until you come to the Racine's range sign. Turn north onto the range road. Travel on the range road to the 100yd range.

RULES: Current NRA Smallbore Rifle rule apply. Open bolt indicators (Rule 3.21) and eye recommended and ear protection are required.

ELIGIBILITY: State Event is open to any individual member of Wi-FORCE and NRA or any member of an NRA-affiliated Junior Rifle Club.

EQUIPMENT:

- NRA Match Rifle - 22 Rimfire rifles
- Service Rifle - 22 Rimfire uppers
- Iron and Any Sight Rifle -- the iron sight may include corrective or noncorrective lenses (rule 3.7)
- Sling pads and cuffs will be allowed.

ENTRY FEES: Competitors fees: Day 1 \$15.00; Day 2 \$15.00; Both days \$30.00

SQUADDING Competitor who fails to present himself/herself at the proper firing point when his/her relay is called may lose his/her right to compete in that event.

ORDER OF FIRING: 50 yards prone stage firing 40 rounds on the A-23/5 Target
50 yards prone stage firing 40 rounds on the A-27 Target
100 yards prone stage firing 40 rounds on the A-25 Target

Time allowance will be one minute per shot and all sighthers must be fire is part of your record time limit.

COURSE OF FIRE:

Day 1

Match 1: 50 yards prone , unlimited sighters : 20 shots for record in 1 20 shot stages. 22 rifle any sights;

Match 2: 50 yards prone , unlimited sighters : 20 shots for record in 1 20 shot stages. 22 rifle any sights

Match 3: 50 yards prone , unlimited sighters : 20 shots for record in 1 20 shot stages. 22 rifle any sights;

Match 4: 50 yards prone , unlimited sighters : 20 shots for record in 1 20 shot stages. 22 rifle any sights

Match 5: 100 yards prone , unlimited sighters : 20 shots for record in 2 10 shot stages. 22 rifle any sights

Match 6: 100 yards prone , unlimited sighters : 20 shots for record in 2 10 shot stages. 22 rifle any sights

Match 7: Aggregate of matches 1,2, 3,4, 5 and 6

Day 2

Match 8: 50 yards prone , unlimited sighters : 20 shots for record in 1 20 shot stages. 22 rifle metallic sights;

Match 9: 50 yards prone , unlimited sighters : 20 shots for record in 1 20 shot stages. 22 rifle metallic sights

Match 10: 50 yards prone , unlimited sighters : 20 shots for record in 1 20 shot stages. 22 rifle metallic sights;

Match 11: 50 yards prone , unlimited sighters : 20 shots for record in 1 20 shot stages. 22 rifle metallic sights

Match 12: 100 yards prone , unlimited sighters : 20 shots for record in 2 10 shot stages. 22 rifle metallic sights

Match 13: 100 yards prone , unlimited sighters : 20 shots for record in 2 10 shot stages. 22 rifle metallic sights

Match 14: Aggregate of matches 1,2, 3,4, 5 and 6

Match 15: Aggregate of matches 7 and 14

AWARDS: Award will be given to the overall Individual winner of matches 7, 14 and 15.

NOTE: Tie scores will be broken with one or more shoot-offs, each consisting of unlimited sighters and 10 shots for record.
