DATE-TIME: Saturday, May 22, 2010, – 600 Yard Matches 9:00 A.M.

Sunday, May 23, 2010 – 80 Round Regional Match Course 8:00 A.M.

LOCATION: Wisc. Rapids, WI (Drive south of Expressway Bridge on Hwy 54 -2 miles to Seneca Rd - Right on Seneca -3 miles to Range Rd {dirt rd begins at 1.8 mile pt}- Right on Range Rd ¼ mile to Range Entrance left).
Camping available at range.

ELIGIBILITY: Competition open to any current NRA member or U.S. Armed Forces.

RULES: Current NRA rules and classifications system will be used in all matches.

PIT SERVICE: Competitors will score and pull targets.

MATCH SCHEDULE: Saturday –600 yards, slow fire, prone-MR-1 targets (check in time closes 8:45am)

2 sighters and 20 rounds for record SELECT ONLY 4 MATCHES TO FIRE.

MATCH 8 – NRA Match Rifle or Palma Rifle – iron sight

MATCH 9 – NRA Match Rifle or Palma Rifle – any sight

MATCH 10 – Any Rifle – any sight

MATCH 11 – Any Rifle – iron sight

MATCH 12 – Service Rifle

MATCH 13 – Aggregate of four fired 600 yard matches

MATCH SCHEDULE: Sunday – 80 round Regional Match Course (check in time closes 7:45am)

MATCH 1 – Standing SF 2 sighters, 20 record shots, 200 yd-SR target

MATCH 2 – Sitting RF 2 sighters, 20 record shots, 200 yd-SR target

MATCH 3 – Prone RF 2 sighters, 20 record shots, 300 yd-SR3 target

MATCH 4 – Prone SF 2 sighters, 20 record shots, 600 yd-MR-1 target

MATCH 5 – Slow fire aggregate, matches 1 and 4

MATCH 6 – Rapid fire aggregate, matches 2 and 3

MATCH 7 – Aggregate of matches 1 thru 4

AWARD SCHEDULE: NRA points a 10% award schedule will apply-if there are less then 5 competitors entered in a class they will be combined with the next higher class-if there are less then 5 competitors in the High Master class they will be eligible for match winner awards only (High master and Master will not be combined).
