- Dates:** September 25, 2010
- Location:** Off of Hwy LS, North of Sheboygan, WI - See map on clubs web site

- Facilities:** 15 covered points with turning targets at 25 yds and stationary targets at 50 yds.
- Eligibility:** Open to any member of the NRA
- Match Entry Fees:** 10.00 per gun or \$15 for Across the Board plus \$5.00 Registration fee (\$4.50 to NRA)
- Entries:** Will close 15 minutes before relays are scheduled to start
- Relays:** Relay #1 – Saturday 9 AM Relay #2 – Saturday 1 PM
- Rules:** Current NRA pistol rules will apply
- Scoring:** Competitors will score and change targets. Scoring plugs will be restricted to range personnel only. A fee of \$2.00 will be charged for each challenged target. Fee will be returned if challenge is sustained.
- Classification:** NRA classification system will be used. Any class with less than five entries will compete in the next higher class. If there less than five entries in the High Master class, they will compete for match winner only.
- Safety:** **USE OF EYE AND EAR PROTECTION IS REQUIRED BY ALL COMPETITORS.**
