3. **The Grantee shall furnish written reports as to the progress and conclusions reached with respect to activities financed by the grant, including a summary of funds expended.**
4. Any violation of the conditions set forth herein will permit the WFNRA Block Grant Fund to terminate any and all further distributions to the Grantee whether or not such distributions have been properly promised or pledged.
5. It is expressly understood that the Grantee takes full and complete responsibility in carrying out the event, that the Grantee holds Heritage Shooting Inc. the WFNRA Block Grant Fund and the NRA harmless from any and all liability relating to the effectuation of this grant and further, that the Grantee shall indemnify Heritage Shooting Inc. and the WFNRA Block Grant Fund from any claims made or actions taken, as a result of this grant.
6. It is expressly understood that the WFNRA Block Grant Fund has made this grant based upon the information provided by the applicant/Grantee and that the HSI/WFNRA Block Grant Fund shall not be held responsible for the consequences resulting from the making of this grant.
7. Publicity associated with the presentation of this grant in the form of photos, video, or news articles, may be utilized by
